1.01 It is informed that the 1st meeting of the Alumni of the IFTM University and erstwhile IFTM & CET was held on January 11, 2019. The highlights of the minutes are as follows:

- It was decided that the IFTM University Alumni Association may be conducted on March 01, 2019 and Alumni may also be invited for 'Samavesh' (Annual Cultural Day) which is scheduled the very next day that is March 02, 2019.
- The Executive Committee of the IFTM University Alumni Association was finalized and it was decided that the registration of the IFTM University Alumni Association may be done under the Societies Act 1860.
- The Committee of 04 members was constituted to frame the Bylaws etc. of IFTM University Alumni Association.


➤ Taken Note of and it was informed that 'Samavesh' has been rescheduled on March 14, 2019 and all the alumni present are invited.

1.02 (a) It is informed that the application for registration of IFTM University Alumni Association (IUAA) under the Societies Act 1860 has been submitted with the copy of Bylaws and necessary documents. The main highlights of bylaws are as follows:

- Formed with the aim to have regular and continuous interaction with the alumni.
- The membership fee of Rs. 100/- (annual) and Rs. 1000/- (lifetime) and separate bank account in the name of IFTM University Alumni Association shall be opened.

(b) It is informed that the annual membership fee of the IFTM University Alumni Association which is Rs. 100/- has been waived for the alumni present here in the meeting today.

- The same was welcomed by the Alumni and accordingly the annual membership of the alumni present in the meeting will be expired on February 28, 2020 and can be renewed by paying Rs. 100/- as annual membership fees before expiry.

1.03 The erstwhile Institute of Foreign Trade & Management was popular as IFTM. Likewise it is proposed that the IFTM University Alumni Association may be popularly called as 'IUAA'.

- The same was appreciated by all and was approved.

1.04 As per the Societies Act 1860, it is mandatory to elect the office bearers like President, Vice-President and Joint Secretary. Hence, it is proposed that an advertisement may be floated among the Alumni to seek the nomination for the aforesaid office and election may be conducted in the next meeting of IFTM University Alumni Association (IUAA). Till then the interim office bearers shall work.


- It was decided that the advertisement seeking the nominations may be floated only among the alumni who are either the annual member or life time member of IUAA and else was approved.

1.05 In order to strengthen the IFTM University Alumni Association (IUAA) it is proposed that an Alumni Co-ordinator may be appointed at each School amongst the old faculty member preferably who are alumnus, to enrich the available database and for regular interaction with the alumni. The names may be invited by the Directors of the concerned 11 Schools of the University.

- The same was approved

1.06 It is proposed that Alumni may be invited to the meetings of statutory bodies like Executive Council, Academic Council, Board of Studies etc. and also for innovative talks, lectures etc. to fetch their valuable inputs which may cater to the development of the University.

- It was decided that the Directors of all the schools may assess the requirement of participation of the alumni in the various statutory meetings of the University and may submit the names of the alumni to the alumni cell of the University which will take further necessary approvals for inviting the alumni


- The preferable time for the conduction of meetings of IUAA may be as follows:
