Research/Review article published with affiliation of IFTM University in Scopus/Web of Science indexed journal and having SCI impact factor less than 5.0	Rs. 8000/ will be paid to corresponding author as first author with a condition that He/ She will retain 60% of provided amount himself/herself and rest of 40% amount should be equally shared amongst all other co-authors. In case of single author, entire amount will be retained by Corresponding author.
Research/Review article published with affiliation of IFTM University in Scopus/Web of Science indexed journal and having SCI impact factor 5.0 or more than 5.0	Rs. 22000/ will be paid to corresponding author as first author with a condition that He/ She will retain 60% of provided amount himself/herself and rest of 40% amount should be equally shared amongst all other co-authors. In case of single author, entire amount will be retained by Corresponding author.

The processing charge will be reimbursed upon production of receipt in original and after publication and getting the patent granted.</p> <p>3. The Separate incentive including processing charge may be given to first applicant upon recommendation by Monitoring Committee & approval of Hon'ble Vice Chancellor, subjected to maximum Rs. 18000/-</p> <p>4. If the first applicant/patentee is "IFTM University, Moradabad" then the incentive including processing charge may be given to second applicant or first investigator upon recommendation by Monitoring Committee & approval of Hon'ble Vice Chancellor, subjected to maximum Rs. 25,000/-.</p> <p>5. In case of single author, entire amount will be retained by corresponding author.
For Ph.D. Scholars	The faculty members who are pursuing Ph.D. from IFTM University, Moradabad will be offered for a special discount in their Ph.D. fees*.
On award of Ph.D. Degree	Three increments will be given to the Assistant Professor on his/her basic salary upon recommendation by Monitoring Committee & approval of Hon'ble Vice Chancellor.
