(57) Abstract :

Herbal cosmetic formulation for skin care The present invention relates to a herbal cosmetics composition comprising: 02 % (W/V) Guava leaf oil, 02 % (W/V) Wheat germ oil, 0-10 % (W/V) Jojoba oil, 0-10 % (W/V) Hemp seed oil, 5 % (W/V) Rose oil, 70 % (W/V) Aloe vera gel, 5 % (W/V) glycerin and 7% (W/V) nonionic surfactants for skin care by inhibiting the changes in stratum corneum of epidermis upon UV/Sunlight exposure, wrinkling, spongosis, collagen bundle disorientation, ultra structural changes in collagen fibers, photo allergic dermatitis, hyperkeratosis, photo aging of the follicular mouths, Liquefaction degeneration of the basal cell layer of the epidermis region.
