**(57) Abstract :**

The present invention relates to anti-obesity formulation. More particularly, the methanolic polyherbal formulation for treatment and management of obesity and associated complications, said formulation comprising extract of Agnimotha, Allium sativum, Chitrak, Green tea, Momordica chitrak, Mustak, Piper nigrum, Punarnava and Vacha, wherein, each of the extracts contains 0.01 to 10 parts by weight based on 100 parts by weight of the total composition. The formulation changes the SGPT level upto 8% after treatment with 100-200 mg/kg body wt of Wister albino rat.
